

**Can't Beat Raven Contest Rules**  
**WEZN-FM AND WALK-FM OFFICIAL RULES**

1. **NO PURCHASE NECESSARY TO ENTER OR TO WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**
2. **Eligibility.** Subject to the additional restrictions below, the **Can't Beat Raven** Contest is open to residents of the state of **Connecticut or New York** who are 18 years or older at the time of entry. Employees of **Connoisseur Media** ("Sponsor"), and each of *its/their* respective affiliated companies, subsidiaries, and advertising and promotional agencies, and the family members of, and any persons domiciled with, any such employees, are not eligible to enter or to win. The term "family members" includes spouses, parents, grandparents, siblings, children, grandchildren and in-laws, regardless of where they live.
3. **How To Enter.** The Sweepstakes will begin at 12:01 a.m. (E.T.) on **Monday June 1<sup>st</sup>, 2020** and end at **a date to be determined.** (the "Sweepstakes Period"). Sponsor will be the official timekeeper for the Sweepstakes.

To enter, listen to Sponsor's Anna & Raven radio broadcast (the "Show") each weekday during the Sweepstakes Period. Every weekday during the Sweepstakes Period **before 8:10am**, Sponsor will announce **it is time to call in to play "Can't Beat Raven."** When you hear the announcement, call Sponsor's Sweepstakes Line at 800-330-9999 to be selected to play the game. Subject to verification of eligibility and compliance with these Official Rules, the selected person to call Sponsor's Sweepstakes Line, as solely determined by Sponsor, will compete against Raven.

Raven will leave the Room. The contest will be asked to answer 5 trivia questions. Once the Answers are recorded Raven will be called back into the room and will answer the same 5 trivia questions. If the contest gets more right answers than Raven, the contestant will win the money in the "pot." The pot will start at \$100 and increase \$100 every time Raven wins.

Listeners accessing Sponsor's radio station audio via IP connections like website-based streaming or mobile devices are welcome to enter. However, Sponsor cannot be responsible for delays in electronic transmission of station audio to IP devices. By entering this Sweepstakes, listeners acknowledge and agree to this specific provision of these Official Rules. In addition, Sponsor will not be responsible for loss of service to the Sweepstakes Line or for a participant's failure to reach the Sweepstakes Line due to malfunction of any network or system, congestion, any technical or human error, failures or malfunctions of any kind, including the congestion, overload, busy signals, or any other factor that may prevent an individual from completing his/her phone call.

Sponsor reserves the right to disqualify any entries by persons who submit false or misleading entry information or who Sponsor determines to be tampering with or abusing any aspect of the Sweepstakes.

4. **Prize Description.**

**Prizes:** Subject to verification of eligibility and compliance with these Official Rules, Winner will receive **the amount of money in the prize pot with a minimum prize of \$100.** The prize will increase \$100 per day every time Raven wins. After a win the pot will start at \$100.

Prizes will be fulfilled approximately within 4 weeks after the contestant has won.

5. **Winner Notification and Acceptance.** Winners will be notified at the time of the contest.
